This email misrepresents the rules to justify handing names to China. Rule 7.1 of the rules of procedure of the Human Rights Council says rules of the former Commission on Human Rights apply if not expressly changed. The Commission rule was that delegations must ask about accreditation status in public, not in secret email exchanges with UN bureaucrats.

Trust of the Chinese delegation overrides rules? Dear June and colleagues. I was briefed by Emma on your meeting with the Chinese delegation. As far as I am concerned the matter is plain. The Chinese delegation will send us the usual note concerning those individuals who have been or will be accredited to the session. To do this they need to get a confirmation of the presence of one or more of the listed individuals during HRC12. Since the list of participants to a UN public meeting is by definition public there is not much we can do to resist their inquiry. The best we can do is delay by few days (until 25 February) the confirmation of those present in March but this will amount to nothing and will exacerbate the Chinese mistrust against us. We'll have more leeway at a later stage and we all know that security will eventually authorize the NGOs participants to attend the session. Finally, I would like to add that I would find it appropriate for the NGO concerned to be informed about the Chinese request.... transparency goes both ways. Cheers, eric

Dear Eric,

As you know, the Forum is open to non-ECOSOC NGOs and has a defined procedure for accreditation (see excerpt from 19/23 below). In the case of the Forum, last year the list of accredited participants was made available and updated on the Extranet prior to the Forum; this year the updates of the list were provided upon request (China's request resulting in the usual exchange of NV regarding security concerns).

Decides that the Forum shall remain open to the participation of States, United Nations mechanisms, bodies and specialized agencies, funds and programmes, intergovernmental organizations, regional organizations and mechanisms in the field of human rights, national human rights institutions and other relevant national bodies, academics and experts on minority issues and non-governmental organizations in consultative status with the Economic and Social Council; the Forum shall also remain open to other non-governmental organizations whose aims and purposes are in conformity with the spirit, purposes and principles of the Charter of the United Nations, based on arrangements, including Economic and Social Council resolution 1996/31 of 25 July 1996, and practices observed by the Commission on Human Rights, through an open and transparent accreditation procedure in accordance with the Rules of Procedure of the Human Rights Council, which will provide for the timely information on participation and consultations with States concerned;

On your question, at HRC21, 729 temporary NGO badges were issued for Room XX; HRC20 - 465. This does not include NGO reps with Annual badges, side event badges (around 250-300 at each session) and public gallery badges (around 100).

Having consulted with June, of course we would not favour providing this information to the Chinese Mission. We notice that their requests are more frequent and concern not only the Council, but also Treaty Bodies sessions and our own OHCHR meetings, so providing such information means potentially opening a door to further requests and endangering the participation of legitimate NGOs in the UN fora. If necessary, we are ready to meet/talk with the Mission..
